**Administrative Park Rules and Regulations**

Updated 3/2011

The Village of Glendale has 5 active parks and 9 passive parks  
Reservations can be made for use of 4 of the 5 active parks.  
Parks are available on a limited basis to residents and (limited) non-residents.

**Washington Park;** Picnics, soccer, baseball, basketball

**Summit Park;** Picnics, soccer, baseball, tennis

**Lake Park;** baseball

**Saunders' Park;** baseball

***Purpose;***

There is great demand for our recreational fields and flexible Administrative policies are necessary to protect both the condition and availability of the fields. Over 1,000 families pay taxes to provide and maintain these 4 recreational parks and the Village of Glendale will strive to share the time fairly and equitably among all of these taxpayers. The Village Administration reserves the right to amend these policies when in the best interest of the Village. Amendment(s) may include limiting time availability, day availability and or denial of use. Should a sport activity be deemed too harsh, inappropriate or injurious to the physical condition of the park(s), an application may be rejected. Failure to follow procedures and or rules will also result in rejection of present and future use. Those continuing to violate these rules and or regulations, after receiving reasonable notice, may be prosecuted in the Glendale Magistrate Court under section 96.02.

**When A Permit Is Necessary;**

- Groups of 6 or more persons require a permit
- Organized sports or sport events require a permit
- Organized picnics by a non resident or non business entity

**Glendale fields are available to residents and non-residents as follows:**

- 1) Organized sports with at minimum of 50% active residential (Glendale) children have first priority and are exempt from user fees.
- 2) Residents (Glendale) utilizing the parks for unorganized family member sports, events and picnics have second priority and are exempt from user fees \*.
- 3) Organized sports with less than 50% but greater than 25% active residential (Glendale) children have third priority and will receive a 50% discount of base user.
- 4) Organized sports with no or less than 25% active residential children have a fourth priority and will be subject to normal user fees.

2011 User Fees;	<b>\$100.00 per day</b>
	<b>\$50.00 per day at 50% Factor</b>
	<b>\$25.00 per day at 25% Factor</b>

**Glendale Park Picnic areas are available to residents and non-residents as follows:**

- 1) Residents may reserve any picnic area on a first come basis at no charge, subject to a \$50 refundable security deposit.
- 2) Non-residents and non-businesses may reserve any picnic area on a first come basis at the **2011 User Fee** for one day at no reduction factor, subject to a refundable security deposit of \$50.

No one team, organization, person or entity shall be permitted to reserve more than 3 days per 7 day schedule. No one team, organization, person or entity shall be permitted to reserve a park or field for more than 3 hours on average in any one day for games and or practices.

Rainouts of organized GYS Sports activities may cause the cancellation of non-resident scheduled events and may allow for temporary exceptions of aforesaid rules, subject to the Scheduling Administrator's approval.

Tournaments are limited to one per season per team.

Concessions, charges, admission fees, advertising is expressly prohibited on or about Glendale Recreational property and parks.

Modification to facilities, equipment, painting, or other changes to that which is established is prohibited without the Village Administrator's approval.

\* In order to provide residential impromptu and non-organized residential use of the 4 parks, 15% of the field time (one day) is set aside for this use each week and will not be reserved.

**Ordinance 2006-22**

**AN ORDINANCE CREATING SECTION 96.02; PARK RULES & REGULATION, OF THE GLENDALE CODIFIED ORDINANCES, TO ALLOW POLICE ENFORCEMENT OF ADMINISTRATIVE PARK RULES AND OR REGULATIONS**

BE IT ORDAINED, by the Council of the Village of Glendale, State of Ohio, three-fourths of all members elected thereto concurring:

SECTION I: That Section 96.02 Park Rules & Regulations, of the Glendale Codified Ordinances, upon affirmative notice and pertaining to the prohibition of violations of the rules and regulations governing the use of Village parks, is hereby created, as detailed in the attached exhibit "A" .

SECTION II: This ordinance is hereby declared to be an emergency measure for the purpose of the timely and efficient administration of Village affairs, the immediate preservation of the public peace, health and or safety, as provided by Ohio Revised Code 731.30, and shall take effect immediately upon passage.
