- 1.) Reconstructed the Village Square via an OKI grant for apx. \$500K and a stimulus grant for apx 250K, capping the Village's expense at less than \$150K.
- 2.) Employees given a CPI adjusted merit raise.
- 3.) Received 14th annual Tree City USA Award *and* Growth Award.
- 4.) The fire Department officially began serving the village as a stand-alone fire department.
- 5.) The village received a 100% Achievement Recognition Award from The Bureau of Workers Compensation & BWC costs were again dramatically reduced, saving 100K.
- 6.) Hosted annual Memorial Day Parade with State Representative Connie Pillich as the keynote speaker.
- 7.) Wastewater treatment plant completed and dedication ceremony held.
